Japanese Intellectual History of Chinese Studies - Micro-identity and Macro-civilization –

Work during the one-year project has directly produced two monographs of the intellectual history project, pertaining specifically to the evolution of China studies in contemporary Japan, and three research trips taken by Professor Shao Hsuan-lei to coordinate for the continuation of the oral history projects in the years to come. Indirectly, in cooperation with other projects and grants, the research and publication directly coming out of this project are fully presented for a number of times in different institutions in Taiwan, in China, and in Europe. These other occasions took place primarily in the form of workshop and conference. In addition, the Department of Political Science of National Taiwan University supported a theme workshop at the end of 2013 on East Asian international relations and intellectual history that reserved a whole day (December 15) for both the presentation of the two oral history monographs and discussion as well as feedback from the audience, which include participants from a number of Asian countries, such as Malaysia, Vietnam, Mainland China, and Korea in addition to Japan.

Both Professor Hirano Kenichiro, an interviewee himself in one of the published volumes and the leader of the first series of oral history interviews of this project, and Professor Baba Kimikiko, likewise an interviewee himself in the published book, attended a gathering associated with this project at different times and provided practical advices as to the possibility of publishing the Japanese version of the book.

The three trips to Japan brought Professor Shao Hsuan-lei to be in contact with Professor Shigeo Nishimura, Dr. Kimikiko Baba, Professor Tanigaki Mariko, Professor Takeshi Hamashita, Professor Kenichiro Hirano, Professor Hajime Osawa, Professor Kojima Katsuko, and other researchers. He discussed the arrangement for continuing interviews in 2013 as well as for 2014 and onward. He also reflected with the hosting colleagues on the problems and mistakes of the two published volumes. A table of mistakes and correction will be manufactured in the near future to go along with the published monographs when they are provided and mailed as gift to institutes or visitors.
