## **COMPLETION REPORT**

Towards a Socially-Inclusive Creative City: What George Town world Heritage Site Can Learn From Japan?

Renowned Japanese creative city scholar, Masayuki Sasaki, has acknowledged Kanazawa as a socially-inclusive Creative City. This study aims to examine the ways towards becoming a socially-inclusive creative city for George Town World Heritage Site by gleaning lessons from Kanazawa, Japan - a UNESCO Creative City of Crafts and Folk Arts designated in 2009. A comparative study between Kanazawa, Japan and George Town World Heritage Site, Penang was undertaken where the researcher carried out fieldwork in both cities. A purely qualitative research approach was adopted where primary data were collected through interviews, focus group discussions and field visits in both cities. Purposive and snowball sampling methods were engaged to identify key informants. A total of fifteen (15) interviews and four (4) focus group discussions were conducted in George Town with government agencies, State Executive Officials, Non-Government Organisations, independent consultants, heritage traders, artists, the private sector and local think-tanks. In Kanazawa, four (4) interviews and two (2) focus group discussions took place with City Hall officials, directors of cultural institutions, artisans and the private sector. From the interviews and focus group discussions, the requirements for GTWHS to be a socially inclusive Creative City are: i) strong state intervention, ii) distinct cultural and creative policies that integrate the elements of social urban inclusion, iii) adequacy of infrastructure, resources and support system, iv) availability of packaging, branding and marketing mechanisms for creative/cultural products, and iv) efforts to mitigate the downsides of gentrification. The study also identified several issues, challenges and barriers faced by GTWHS such as: (i) ignorance towards the Creative City concept, (ii) fragmented and disorganized efforts by various stakeholders, (iii) non-symbiotic coexistence of heritage craftsmen and modern artists/entrepreneurs amidst gentrification, (iv) shortage of successors for heritage trades, and (v) existing Malaysian education system that does not prioritize the cultivation of arts and culture. This study also analyzed Kanazawa's strategies and policies, and they were organized under five subthemes, namely, a) foundations, b) people, c) planning, d) markets and e) visions. Under the theme 'foundations', Kanazawa's history is integral towards the city's success as a socially inclusive Creative City. Under the theme 'people', it was found that Kanazawa's craftsmen possess a great sense of pride in their work thus contributing to the success and sustainability of the city's creative industries. The people of Kanazawa's high awareness and appreciation towards arts and culture also help to support local creative economy. Under the 'planning' theme, Kanazawa is a city with integrated physical planning and design, excellent museums and galleries complemented with good infrastructure and local communities to support the city's arts and local culture. Under the theme 'markets', Kanazawa positions and embeds culture in business. Kanazawa citizens mostly opt for original (instead of imitation) products, and the city has good packaging, branding and marketing mechanisms. The theme on 'visions' disclosed that Kanazawa has past leaders with foresight and their visions are continued by contemporary ones. Key recommendations: i) to incorporate multi-dimensional policy-making in George Town; ii) to ensure George Town's urban planning, design and use of public spaces integrate a cultural approach; iii) to utilize George Town's cultural endowments for all citizens to foster social inclusion.
