Examining Identity and Belonging of Youth Descendants of Japanese-Indonesian International Marriages Living in Japan and Indonesia: A Comparison

Title: Examining Identity and Belonging of Youth Descendants of Japanese-Indonesian International Marriages Living in Japan and Indonesia: A Comparison

The study examines the dynamic of identity negotiation of biethnic youths from Japanese-Indonesian marriages focusing on the influence of complex cultural schemes, knitted social structures, familial heritage and traditions, and attachment to society. The focus is the youths' subjectivity and agency as they embrace, resist, navigate and compromise their identity and belonging.

This study is qualitative research with in-depth interviews. The fieldworks were conducted in Japan in two periods (on August and November 2019) and in Indonesia in seven periods (in the span of May to November 2019). In-depth interviews were conducted to 30 biethnic youths aged 13 to 23. The analysis uses descriptive and interpretive methods.

The study finds that multiple contesting cultures during their formative years prompted biethnic youths to be adaptive in their present group. Giving importance to the influence of cultural affiliation, cultural connection to the other group, country of residence, current citizenship, education environment, parent's social class, and religious affiliation, biethnic youth constantly negotiate and adjust their preference to be acknowledged and accepted by their chosen group. In female interviewees, intersectionality issues related to gender and gender roles brings complexity and bigger challenges in their identity formation. This study concludes that biethnic youths, descendants of Japanese-Indonesian parents, create a third identity of hybrid culture to secure an imaginary space for themselves in the society.

Future recommendation:

International marriages will be increasing in the future due to rapid migration (temporary and permanent), globalization, and technological advancement. Research on how to understand the potency of new generation with global aspirations, viewpoints and identities should be prioritized. Also, research on how to prepare the society to be more adaptive and inclusive.
