## **COMPLETION REPORT**

The grantee was able to finish the study titled *Roles and Purposes of Graduate Journalism Education in the Lens of Global Journalism:* A *Phenomenology*. The researcher interviewed 16 graduate students from Japan's Waseda University (11) and the Philippines' Ateneo de Manila University (2) and the Asian Institute of Journalism and Communication (3). Also interviewed were the master's in journalism program heads. The researcher sought to find out from Japanese and Filipino graduate journalism students the roles and purposes of journalism graduate studies on them, with phenomenology as its research design.

An output of the paper, given the answers of the respondents, is the formulation of a *Bridge of Traits of Graduate Journalism Education*. Students find their graduate studies in journalism as: a) Insights maker; 2) Context provider; 3) Role agent; 4) Capacity builder; and 5) Individual booster. The paper is a response to the dearth of studies worldwide on graduate journalism education —remarked to be a venue to "retrain journalists" (Folkerts, 2014) and to make practicing journalists become practitioner-scholars.

A struggle faced by this paper is to get practicing journalists to be respondents, especially in the Philippines. Personal contacts have been exhausted but the busy work of daily journalists is a constraint to make them respondents. A target journalism school in Japan, Nihon University, did not provide any feedback on the researcher's request for respondents and for the school's participation. Nevertheless, having 16 respondents for this phenomenological research satisfies the methodological rigors of the said qualitative research design.

The research project contributes to studies worldwide on graduate journalism education. At the moment, some scholars (Folkerts, Lemann and Hamilton, 2013; Folkerts, 2014; Schultz, 2022) have put demarcation lines on the difference between undergraduate and graduate journalism education. Answers from the 16 respondents tend to show the operationability of the visions to graduate journalism education, from students' point of view.
